



**Independent statutory auditor's report on the review of the
interim condensed consolidated financial statements for the period
from 1 January 2013 to 30 June 2013**

For the Shareholders and Supervisory Board of Echo Investment S.A.

We have reviewed the enclosed interim condensed consolidated financial statements of the Echo Investment S.A. Capital Group (later referred to as the "Group"), whose parent company is Echo Investment S.A. ("Parent Company"), with registered office in Kielce in Al. Solidarności 36, comprising the consolidated interim statement of financial position as at 30 June 2013, consolidated interim profit and loss account, consolidated interim statement of comprehensive income, consolidated interim statement of changes in equity, consolidated interim cash flow statement for the period from 1 January to 30 June 2013, notes on the adopted accounting principles and other explanatory information.

The Parent Company's Management Board is responsible for preparing interim condensed consolidated financial statements in line with the International Financial Reporting Standards approved by the European Union and related to financial reporting (IAS 34). Our task was to produce a report on these interim consolidated financial statements based on the conducted review.

The review has been conducted according to the national financial reviewing standards issued by the National Chamber of Statutory Auditors. The standards require us to plan and conduct the review in such a way so as to obtain reasonable certainty that the interim condensed consolidated financial statements are free from material irregularities. The review has been conducted mainly by way of analysing the data in the consolidated financial statements, inspecting the consolidation documents and using the information provided by the management and persons responsible for the Company's finances and accounting.

The scope and method for reviewing the interim condensed consolidated financial statements differ significantly from audits based on which opinion is given on the compliance of consolidated financial statements with the applicable accounting principles (policy) and that such statements are true and fair. Therefore, we cannot produce such an opinion on the enclosed statements.
